# Kenya's tree planting drive hits 783 million mark

This feat has been achieved through a collective effort by Kenyans, corporates, the private sector, state agencies, ministries, and departments.

The Cabinet Secretary for the Ministry of Environment, Climate Change and Forestry, Deborah Barasa, said that the private sector has played a critical role, supporting smallholder farmers to participate in the tree-growing campaign.

Speaking in Kakamega during the launch of One Acre Fund's Tupande Tree Growing Initiative 2025, the CS said the ambitious goal to plant 15 billion trees by 2032 is a promise to future generations and a testament to collective efforts to combat climate change, restore ecosystems, and secure a greener, more prosperous Kenya.

She noted that One Acre Fund, through the Tupande programme, has already planted an impressive 97 million trees

## Kenya Power eyes 150,000 connections in new electrification phase

renya Power aims to connect 150 000 customers **L** to the national grid under Phase VI of the Last Mile Connectivity Project (LMCP).

The project, funded by the African Development Bank (AfDB), targets households and Micro, Small, and Medium Enterprises (MSMEs) spread across 45 counties—excluding Nairobi and Mombasa.

"The Government of Kenya has received financing from

The funding will significantly boost the ongoing national electrification efforts and accelerate the attainment of universal access to electricity by the year 2030," said Kenya Power's Managing Director and CEO, Dr. Joseph Siror.

"This will involve the construction and refurbishment of 13 substations—including the construction of three new 33/11 kV substations, the refurbishment and upgrade of three existing 33/11 kV substations, and the construction of seven new 33 kV switching stations," he

The project will also involve the construction of 211 kilom eters of 33 kV distribution lines and 14 kilometers of 11 kV lines to enhance social infrastructure supporting education, healthcare, water, and sanitation services.

Additionally, 650 kilometers of 33 kV lines and 6,798 kilometers of low-voltage network will be constructed to support

# Kenya's tree growing campaign reaches 783 million milestone

across Kenya, distributed to over 1.4 million farmers and 37,000 institutions.

The organization has set a target to distribute 46 million tree seedlings to institutions, farmers, and individuals through its 330 operating nurseries spread across the country this year. The progress of the trees is tracked through the Jazamiti App.

"Tupande Nursery propa-gates over 20 indigenous, exotic, and fruit tree species. The 330 tree nurseries are spread across 34 counties. Remarkably, 25 percent of these nurseries are owned and operated by women, proving that this movement is also about empowerment, equity, and opportunity," the CS noted.

She disclosed that Kakamega County has grown 21 million trees and has set a target to grow 20.86 million trees annually to achieve 30 percent tree cover, up from the current 18.21 percent.

Tupande Director Michelle Kagari said the organization's goal is to support farmers in planting trees within their parcels of land to reverse deforestation and reduce greenhouse gas emissions.

She noted that One Acre Fund distributed a total of 150 million tree seedlings through schools, churches, hospitals, and direct farmer outreach between 2021 and 2024.

"Farmers can access a variety of tree seedlings for both timber and fruits through our extensive network of nurseries.

These include Grevillea, Makhamia, Cordia, Cypress, Eucalyptus, Grafted Avocado, Macadamia, orange seedlings, passion, tree tomatoes, and pawpaw," she said.

Kagari said the Tupande tree nurseries have also created

employment since they are run by a tree nursery manager with each nursery employing five marketing agents.

"Any farmer who walks into one of our nurseries gets 20 free seedlings before any purchase. For farmers enrolled with Tupande, they get 30 free seedlings for the season, this means that whether a farmer buys seedlings or not, Tupande ensures every farmer can plant trees every season," she added.

To support the initiative, the County Executive Committee Member for Environment, Water, Natural Resources and Climate Change Peninah Mukabane said the Kakamega County Government is supporting tree nursery establishment through the climate change programme.

We are setting up five nurseries this year alone and we have already set up the county climate change governance structure up to the ward level," she said.

Mukabane noted that the county government has partnered with the Kenya Forest Service (KFS), Rhino Ark and Safaricom to erect an electric fence around Kakamega Forest.

We are beginning to see the results of the Kakamega Forest Fencing Project because there is regeneration of natural biodiversity that had since disappeared after some time. The indigenous trees that are used for medicinal plants have also started coming up," she said.

last mile connections.

Kenya Power has invited bids for consultancy services. The selected consultant will be responsible for technical designs, as well as environmental and social performance audits. They will also support the company in procurement and supervision of construction works.

Since the inception of the LMCP in 2015, Kenya Power has connected 746,867 customers to the national grid.

The company is currently implementing the fourth and fifth phases of the LMCP, which seek to connect an additional 280,000 and 11,000 new customers to the grid, respectively.

LMCP has also been funded by various lenders, including the Government of Kenya, the World Bank, the Japan International Cooperation Agency (JICA), the French Development Agency (AFD), the European Union (EU) and the European Investment Bank (EIB).

## State to establish Special Economic Zones in 47 counties

The Government is set to establish Special Economic Zones (SEZs) in various counties to create employment opportunities, empower the youth, and drive

sustainable development.

In a bid to attract investors to these zones, the government has introduced various fiscal and administrative incentives, including exemptions from stamp duty, local government advertisement fees, and business service permits.

During an inspection and verification tour of national government projects in Nakuru County, the Deputy Chief of Staff for Performance and Delivery Management, Mr. Eliud Owalo, announced that the government is set to introduce a new policy framework to limit the number of national projects a contractor can bid for simultaneously. This move is aimed at addressing widespread delays in project delivery.

"As government, we are going to come up with a policy framework — perhaps restricting the number of projects within a given jurisdiction that a contractor can bid for at the same time — so that we don't have these inordinate delays occasioned by lack of capacity on the side of contractors," said Mr. Owalo

The firms will also enjoy preferential corporate rates of 10 per cent for the first 10 years, 15 per cent for the next 10 years and 30 per cent for the subsequent years. Currently, 14 investors have signed up to set up business at the expansive Naivasha Special Economic Zone (SEZ) in Maai – Mahiu.

He said the zone has been expanded to 6,000 acres, from the initial 1,000 acres near the Inland Container Depot in Maai – Mahiu to accommodate more investments and increase job creation.

## Drunk drivers to lose licenses as NTSA reintroduces Alcoblow on major roads

The National Transport and Safety Authority (NTSA), in collaboration with the police, will begin deploying breathalyzers on major roads across the country.

Transport Cabinet Secretary Davis Chirchir announced that any driver found operating a vehicle with alcohol levels exceeding the legal limit will face penalties of up to Sh100,000, a prison sentence not exceeding two years, or both. In addition, the CS warned that anyone convicted of driving under the influence of alcohol will have

their driving licence cancelled for one year.

This initiative aims to combat the rising number of road accidents nationwide.

The CS clarified that recent amendments passed by the National Assembly have reinstated the NTSA's legal authority to enforce drunk driving laws, addressing previous court rulings.

"Consequently, the NTSA will be establishing these checkpoints in accordance with the Traffic (Drink-Driving) Rules, 2025, which were created through the amendment of Section 4 of the Traffic Act, CAP 403," he said. The Cabinet Secretary announced that he had already signed and submitted the updated regulations for re-gazettement, with publication expected this week. followed by immediate enforcement. Moreover, he stated that NTSA had been mandated to oversee inspection of private vehicles through private inspection centers, as well as the inspection of public service vehicles, school transport, commercial vehicles, and vehicles used by driving schools.

## Over 1,000 households in Nakuru informal settlements set to receive title deeds

**¬**he Government intends to provide title deeds and lease certificates to over 1,000 households.

Through Phase II of the Kenya Informal Settlement Improvement Project (KI-SIP), residents of four informal settlements in Nakuru County will gain secure land tenure.

County Lands and Physical Planning Chief Officer Stella Mwaura explained that KISIP Phase II is leading the tenure regularization process in the informal settlements of Turi in Molo Sub-County, Kariandu-si-Gitare in Gilgil Sub-County, Soweto in Njoro Sub-County, and Lagwenda in Kuresoi North Sub-County.

The process is 50 percent complete and is being conducted with the full participation of residents living in the settlements.

Ms. Stella Mwaura acknowledged that land ownership, access, and rights in the county's informal settlements required proper attention to help address perennial land conflicts. She noted that a draft local land use plan for the four informal settlements had already been developed.

"By formalizing land ownership, we empower our communities and unlock opportunities for growth and development,' Ms. Mwaura stated.



## Health Ministry launches NHIF committee to verify pending claims

Ministry of Health has **▲** launched the National Health Insurance Fund (NHIF) Pending Claims Verification Committee.

The committee's primary role is to scrutinize and validate outstanding medical claims submitted between July 1, 2022, and September 30, 2024. It will establish a clear framework to assess the authenticity of each claim, recommend action against fraudulent submissions, and propose reforms to prevent

the future accumulation of unverified claims.

with "Hospitals claims below Sh10 million will be paid without delay, while the remaining nine percent, whose claims exceed Sh10 million, will undergo a thorough verification exercise within 90 days. After that, a payment plan will be agreed upon for all genuine claims," Health Cabinet Secretary Adan Duale said during the launch.

Duale emphasized that the government is committed to settling all legitimate claims.

Addressing concerns over financial constraints in the sector, he acknowledged the challenges facing key healthcare providers but insisted that fiscal prudence must prevail.

"I challenge this committee to identify and root out any fraud or corruption in the healthcare financing system, and where wrongdoing is found, you must recommend the necessary disciplinary or legal action without fear or Favor," said the CS.

Reiterating his stance, Duale warned that the committee would be held accountable for any payments made for services not rendered.

"Every shilling must count value for money, transparency, and accountability are non-negotiable," he affirmed.

He also urged healthcare providers, NHIF management, oversight agencies, and the public to support the committee's work in fostering integrity and fairness.

Committee chairperson James Masiro stated its commitment to delivering accurate, riskbased verification.

"We understand the sensitivity of this task. We will act with integrity, diligence, and teamwork," he said.

## Govt offers duty waiver to feed millers in move to stabilize maize market

The Government will gazette a 50 per cent duty waiver for the importation of 5.5 million bags of yellow maize over a one-year period. In a statement to media houses,

Agriculture and Livestock Cabinet Secretary Mutahi Kagwe said the initiative would be implemented through a vetted list of qualified animal feed millers with sufficient capacity.

"The objective is to reduce pres-

sure on local white maize stocks by shifting animal feed millers to yellow maize," he added. The CS further stated that the move would also enable millers focused on human consumption to access available maize at fairer prices, ultimately leading to reduced production costs and more stable unga prices for consumers.

"The Ministry of Agriculture and Livestock Development notes the growing competition between animal feed millers and maize millers for human consumption over the limited maize grain stocks available in the country. As a result of this increasing demand, the price of a 90-kilogram bag of maize has risen by approximately 26 per cent compared to three months ago," Kagwe noted.

The upward trend in maize prices has directly impacted on the cost of production, prompting millers to pass the increased costs onto consumers through higher prices of maize flour (unga).

Kagwe urged farmers to consider the cultivation of yellow maize to meet the domestic demand of over one million metric tonnes required annually by the animal feed industry.

He noted that this shift would help reduce dependency on imports and contribute positively to the economy.

overnor Amos Nyaribo has commissioned a stateof-the-art mother and newborn unit at Ekerenyo Sub-County Hospital in Nyamira County. This is expected to boost healthcare services in the area and decongest the Nyamira County Teaching and Referral Hospital (NTRH).

'Ekerenyo County Hospital will be the first to offer these specialized surgical services in the sub-county, as the other two facilities are located in Nyamira South Sub-County, in Nyamira town, and Masaba North Sub-County, in Keroka town. This has posed a serious challenge to residents who have had to travel far to access fast and efficient services," Nyaribo stated.

The county boss noted that the neonatal mortality rate was 27 per 1,000 births, while the infant mortality rate stood at 31 per 1,000 live births. He promised to work round the clock to ensure no life is lost during childbirth.

Governor Nyaribo lso thanked the Government of Finland for financing the construction of the modern facility, saying that the cordial relationship and partnership to boost healthcare services in Nyamira County have borne fruit.

"Finland's promise to deliver the project in record time is a sure

indication that the coordination between the County Government of Nyamira and Government of Finland was a very good one and has benefited the people of Nyamira," he said.

## Multi -million water projects to improve food security in Elgeyo Marakwet County

The Government has commissioned the Sh59 million Chebagon Dam and launched the Emsoo Water Distribution Network and School Greening Programme in Elgeyo Marakwet County. This move is expected to boost food security, household income, and environmental conservation in the region. The Cabinet Secretary for East African Community, ASALs, and Regional Development, Beatrice Askul Moe, who presided over the commissioning ceremony, lauded the project, a partnership between the national government and the Elgeyo Marakwet County Government.

She underscored the importance of water security in supporting agriculture, livestock rearing, and domestic

use. "Kenyans need water for many purposes—home consumption, food production, and for their livestock," said CS Askul. "The County Government has done its part, and we are planning to do even more, including installing elevated tanks to serve households farther from the water source," she added.

She also mentioned that the government, through the Kerio Valley Development Authority (KVDA), will construct another dam at a cost of Sh100 million.

Governor Wisley Rotich welcomed the development, describing it as a much-needed intervention in a region with great agricultural potential but limited by water scarcity.

"This dam is a highly welcomed project. Our challenge has always been water," said Governor Rotich. "Our farms have suffered, and incomes have been low. I appreciate KVDA for the excellent work they have done and urge them to expand this support," he said.

The governor encouraged residents to make the best use of the water by planting income-generating crops. "Let us plant seedlings that will generate income for our households. I also urge KVDA to expand their support by providing those seedlings," he added

Governor Rotich emphasized the need for conservation, noting Elgeyo Marakwet's strategic importance as a water tower. "We supply water to almost 10 counties. The conservation of Elgeyo Marakwet is not only for our benefit but also for our neighbors," he said. Emsoo Water Distribution Network costed Sh41 million.

## Sauti SACCO urges retirees to renew membership to access loan benefits

Retiring members of Sauti Savings and Credit Cooperative Society (SACCO) have been urged to renew their membership to continue enjoying easy access to affordable loans for personal development.

SACCO National Chair Mr. Elly Ndwigah explained that the law enacted by the Sacco Societies Regulatory Authority (SASRA) requires that members withdraw all their shares upon retirement. However, this does not prevent members from rejoining the SACCO to continue accessing affordable funds for self-advancement during retirement.

"We will have products tailored for retirees, noting that they can no longer access loans from the SACCO in the same way they did when they were in active employment," Ndwigah said.

He also noted that such members will be guided by separate regulations set by the SACCO, as they no longer have the steady stream of income they once had.

The remarks were made in a speech read on his behalf by Board Member Mr. Milton Odhiambo Omondi during a members' education session in Nakuru for South Rift branch members.

He further noted that despite a decline in membership, the SACCO registered an increase in total loan uptake, from approximately Sh103 million in 2023 to over Sh135 million in 2024.

Dr. Mutua stated that the government is in the process of issuing seafarers' identification documents, which will enable them to work in foreign countries.

"Just like in any other profession, a critical issue for seafarers is the Seafarers' Identity Document (SID). Without this document, securing employment opportunities abroad in the maritime sector is extremely difficult. I will ensure that those without it receive the necessary support to obtain it and unlock access to jobs overseas," he said.

He emphasized the need to address the unique challenges faced by seafarers and commended the extensive groundwork laid to establish the Seafarers' Wages Council.

## Government to vet and publish list of legal labour agencies

Seven countries from the East and Horn of Africa (EHoA) met in Mombasa to discuss ways to protect migrant workers.

They also explored how labour migration can contribute to social development in the region.

Stakeholders discussed the use of social dialogue to address issues affecting migrant workers, strengthen regional cooperation, share best practices, and provide strategic guidance on labour migration governance.

Cabinet Secretary for Labour and Social Protection, Alfred Mutua, said the government has passed bills aimed at ensuring favourable labour migration policies in the country.

The CS warned against unscrupulous agencies luring Kenyans to travel abroad under the pretense of employment.

He stated that the government would conduct a vetting process for all agencies involved in international labour migration and publish a list of those that are officially registered. The CS urged Kenyans to be vigilant and conduct due diligence before signing up with an agency for overseas jobs, advising them to visit the National Employment Agency to confirm whether an agency is registered.

"The government will not allow anyone to be conned. If a registered agency has taken your money and you fail to travel, you will get your money back. For those who do not refund the money, we will take them to court," he said. He added that individuals planning

to travel abroad would also undergo training to ensure they are well-informed and prepared for life overseas. "Some of these recruitment agencies are con artists, and that is why we want to remind people to be vigilant and take responsibility for safeguarding their resources when seeking employment. If you give your money to an unregistered agency, you are exposing yourself to fraud," he said.

Mutua noted that the government has signed bilateral agreements to negotiate on suitable terms that would protect migrant workers. He noted the need for collaboration and social dialogue for players to work together and be able to sort out issues before they arise. On his part, International Labour Organization (ILO) Director General Gilbert Houngbo said labour migration across international

borders is a critical driver of economic and social development in the East and the Horn of Africa (EHoA) region, where millions of workers seek employment opportunities beyond their home countries.

According to the 2022 ILO estimates, there were 167.7 million migrants in the global labor force, Houngbo noted.

He said challenges such as fragmented and weak labour migration governance, lack of coordination, unfair recruitment practices, skills mismatch, limited access to social protection, and limited freedom of association continue to put migrant workers in a vulnerable situation. "In light of this, the third LMAG meeting will focus on the role of social dialogue in improving labor migration governance and discuss how best we engage governments, employers, workers' organizations to address these challenges and ensure safe, regular and orderly labour migration in EHoA region," he said.

The meeting had been organized by the International Labor Organization (ILO).

Speaking when he led a team to inspect various key projects in Uasin Gishu County, the Chief of Staff, Office of the Prime Cabinet Secretary, Ministry of Foreign and Diaspora Affairs (MFDA), Joseph Busiega, pointed out that the inspection aims at establishing the implementation status of the high priority projects and programmes identified within the Rift Valley region. Other key projects visited were Kesses Market, Modernization of New Kenya Cooperatives Creameries - NKCC Eldoret, Expansion of Technical Vocational Education and Training - Eldoret National Polytechnic TTI,

## **Modern market in Narok** nears completion, set to boost local trade

The ultra-modern Uhuru Market in Narok town, being built under the Economic Stimulus Program (ESP) at a cost of Sh358 million, is 44 percent complete.

The market is expected to be finished in 2026 and will accommodate over 800 traders who have been conducting business in open spaces.

Speaking during her tour of the market for inspection, Principal Administrative Secretary in the Office of the Prime Cabinet Secretary, Ms. Juliana Yiapan, expressed confidence that the market would be completed within the stipulated deadline.

"We are impressed with the progress so far. The contractor is ahead of schedule, and this gives us hope that the work will be completed within the timeline." Yiapan said.

She was accompanied by senior officers from the OPCS, including Secretary for Strategy Dominic Magotsi, legal advisor Daniel Ameyo, and senior officers from the Delivery Unit.

The market is one of the major projects the government is implementing in Narok and is expected to be a game changer for Narok residents, who have longed for such a modern facility for years. Seven other markets in different parts of the county are being built at a cost of Sh1.3 billion.

Other areas where the markets are being built are: Ololulunga, Ntulele, Suswa, Emurua Dikir, Mambo Leo, Ewaso Nyiro and Olchoro.

Narok Town Assistant County Commissioner (ACC) Ali Shakur, who accompanied the team, said vegetable vendors and other traders who have been doing business beside the road will have a safer place to do their business.

"Those selling vegetables beside the road risk their lives and suffer harsh weather conditions. The presence of the new modern market will create a better environment for their business," he said

markets come with extra benefits like attracting financial institutions like M-Pesa shops, banks and insurance firms. This will create more job opportunities and boost the livelihood of the people.

Shakur observed that the vision of the current administration is to create job opportunities for the many jobless young people in the country, saying hundreds of youths had been contracted to work in the construction sites.

When the markets are complete, they will contain modern cold storage facilities, modern washrooms, breastfeeding rooms for mothers and will have internet connectivity. The facilities are built with disability-access walkways.

Margeret Wanjiru, a trader at Muthurwa market said the completion of the market will be a big gain to The ultra-modern them as it will offer a comfortable environment to do business and security for their commodities.

She asked the government to prioritize the traders at the market first when allocating the stalls before allocating them to other members of the public.

## Government steps up human-wildlife Conflict compensation efforts

BY MUOKI CHARLES, KNA

The State Department for Wildlife has intensified efforts to compensate victims of human-wildlife conflict to address the huge number of affected beneficiaries.

According to Secretary of Administration Tobiko Nayioma, the department has set aside Sh900 million for the purpose and has compiled a list of victims to be compensated.

The move comes amid rising concern from victims who, despite presenting their grievances and filing complaints, are yet to receive any compensation.

Tobiko attributed the slow pace in compensation that was witnessed sometimes back to the backdating of the victims' list, a matter he said has now been addressed.

"Compensation is done using a list to identify the

victims. However, the list was backdated leading to a slow pace in compensation. We have stepped-up efforts to compensate all victims as soon as possible," Tobiko said.

Human-wildlife conflict has been a major concern for residents of Juja in Kiambu County with victims being killed or maimed by marauding hyenas that live nearby, with victims complaining of lack of compensation despite filing complaints.

Tobiko made the remarks during a tree planting exercise at the Karimenu Dam site in Gatundu North, Kiambu County when officers from the department joined students of Our Lady of Fatima Girls Secondary School, Kiriko, in planting 1,000 trees around the water tower.

On environmental conservation efforts, the Department's Director Publicity and Awareness, Florence Kanana, said they have launched an ambitious programme targeting to plant 100 million trees in a 10-year period. The aim is to conserve the environment as well as mitigate human-wildlife conflict.

She said the initiative would incorporate both primary and secondary school learners as well as work with other agencies including Kenya Wildlife Service (KWS), the Wildlife Research and Training Institute (WRTI), and the Wildlife Conservation Trust Fund (WCTF).

The programme has already been launched in at least five counties - Kiambu, Nandi, Bomet, Baringo and Mount Elgon area in Bungoma- where cases of human-wildlife conflict have been reported.

Kanana added that the department aims to plant 10 million trees annually under the initiative.

"We are aligning our laws with the emerging realities on the ground, global conservation priorities, and the aspirations outlined in the National Forest Policy, 2023," said PS Mugambi.

The eight draft regulations discussed during the forums include guidelines on charcoal production and trade, gums and resins, registration

of private forests, benefit the Amendment Bill include sharing, export and import procedures, participation in forest activities, provisions sustainable forest management, grading and valuation of timber and other forest products, and concessions on public forests.

These regulations are meant to fill policy gaps, enhance coordination, and support sustainable and equitable use of forest resources," he added.

In addition to the regulations, stakeholders were sensitized on the Forest Conservation and Management (Amendment) Bill, 2025, which proposes comprehensive reforms to the 2016 Act.

The Bill seeks to consolidate forest sector institunew bodies such as the Forand the Kenya Forest Law Enforcement Academy.

It also places the Kenya Forestry Research Institute (KEFRI) under the same Act to enhance coordination in research and policy imple-

PS Mugambi noted that feedback collected from stakeholders during the forums will be used to refine the draft legislations before they move forward in the legislative process.

# Nyeri National Polytechnic pioneers use of AI to tackle examination challenges

ot long ago, the examination season was one of the most challenging periods in the academic calendar for Alias Gitau, the Examination Registrar at Nyeri National Polytechnic.

Delivering credible assessments seemed like a straightforward and easy task, but it was far from that for examiners who had to spend numerous hours ensuring that each of the more than 8,400 assessment tools prepared by the institution per academic year met the highest standards.

For years, the process of generating Continuous Assessment Tests (formative assessment) and End of Term Examinations (summative assessment) at the polytechnic was manual. The only digital process involved typesetting and printing the tools, which did not require much time.

To conduct an assessment, a panel comprising internal trainers and industry experts would have to be formed.

The industry experts would be the first to sit for days, set the assessment tools, and then the panel from the Examinations Registrar's Office would follow suit and validate

the tools to ensure the exams met the established standards.

"The process would start at the beginning of the academic year, when Heads of Departments would submit their course planners, which detail the number of units per course and the total number of lessons to be taught under each course. The Examinations Office would then prepare the exam schedule, form the panels, and organize an event where the tools would be set and validated," he said during an interview.

However, that changed four months ago when the institution decided to embrace technology to revolutionize its exam cycle. Gitau said the institution partnered with a local developer to come up with an AI-powered Assessment Generating System named AGEX.

AGEX works using prompts and configurations. Gitau defines the system as a game-changer as it is tailored to eliminate the time-consuming process of having to physically sit and manually set the tools.

The process is largely the same but the only difference is, unlike many AI systems which scour internet for information and generate responses, the AGEX system is fed with the variables it needs -such as the units to be taught per course during the term, the occupational standards which are set by the Kenya National Qualifications Authority, the curriculum, and the learning guide which is developed by the trainersas its knowledge base and point of reference. "The objective is to ensure that the system does not generate assessments outside the scope of the knowledge base," Gitau said.

Before generating an assessment tool, the system is given guidelines in the form of configurations to help it establish whether it is expected to generate a CAT or a main examination. The guidelines are configured to help the system allocate even finer details such as the duration of a CAT or the main exam, the minimum and maximum number of questions to set per section, as well as the marks to be allocated per question.

"For instance, if you want to generate a CAT, you just need one prompt for the AGEX system to retrieve all the information it needs from the knowledge base and it will give you a tool for every course being offered in the college.

"With that one command, the system can

limit itself to the topics that have already been covered. In the case of a summative assessment, the system analyses the entire learning guide per course and uses it to generate a conclusive tool," the registrar explained.

'The system is configured in way that it automatically selects the most suitable framing language for each level of study so that when, for instance, we want to generate, say a Level V, (the Diploma Level) assessment tool, it avoids verbs like 'list' and use verbs like 'elaborate', 'sketch' or 'explain' based on the level of study.

"These guidelines are fed to the system, and it has been trained to ensure that whenever it receives a command to generate a tool, the outcome should align with those requirements," he said.

Not only does the AGEX system generate the exams but also their marking schemes. Once the process is complete, the soft copy versions of the tools are sent to the printer to generate the hard copies.

Gitau said that the moderation of the outcome is still a manual process, and this is where the trainers verify if the questions are in line with the curricu-

# 7,000 principals trained ahead of CBC roll out in Senior Secondary Schools

**BY SHAMIM MUSA, KNA** 

The Government is training 7,000 principals of senior secondary schools across the country on the Competency-Based Curriculum (CBC) as its implementation gains momentum.

In Mombasa, over 100 principals from both public and private institutions attended a training session at Coast Girls' Secondary School, organized by the Centre for Mathematics, Science and Technology Education in Africa (CE-MASTEA).

The training aims to facilitate a smooth transition for Grade Nine learners to senior secondary schools in 2026.

Speaking at Coast Girls' Secondary School, Dr. Patrick Muma, the Director of Decentralized Teacher Management at the Teachers Service Commission (TSC), stated that the training is intended to equip principals with the necessary knowledge to guide new learners and effectively implement the CBC framework by 2026.

"The principals are expecting new Grade 10 learners and are supposed to be informed and prepared. They must guide the learners, as they play a major role in their education," said Dr. Muma, urging principals to adequately prepare for effective implementation.

Dr. Muma explained that there are three key pathways for learners in Grade 10: Science, Technology, Engineering, and Mathematics (STEM); Arts and Sports; and Social Sciences.

He emphasized the need for the principals to understand the subjects and requirements for each pathway, particularly the STEM pathway, for effective implementation of the transition.

"The principals are trained to understand what the tracks and pathways involve. By the end of the training, they should be well-equipped with information on STEM, other pathways, and the relevant subjects," he added.

He also outlined the basic school requirements for the effective implementation of the STEM pathway and emphasized the importance of smooth transitions for Grade nine learners.

The overarching goal of the training is to strengthen the capacity of principals in managing the CBC transition, he said.

Mr. Abuko Thomas, the Principal of Bombolulu Secondary School, expressed his appreciation for the training. He stated that it was essential for understanding the CBC pathways, which differ significantly from the former 8-4-4 system, and better meet students' needs.

He noted that the government recommends at least 60 per cent of students to pursue STEM subjects due to challenges in science performance.

"This training will help us support our students and achieve both government and personal goals of self-sustainability," he

By fostering stronger ties, the two countries will not only address the needs of their labor forces but also open doors for cultural exchange and economic growth, said Labor Principal Secretary Shadrack Mwadime.

He emphasized that the partnership highlights the importance of skilled workers and the mutual benefits of international cooperation in an increasingly interconnected world.


With this new agreement, workers can look forward to more streamlined processes, enhanced protections, and a supportive environment as they navigate employment opportunities abroad, the PS said.

In a significant step for Kenya's labor mobility, PS Mwadime met with a delegation from Germany, following up on the Comprehensive Migration and Mobility Partnership Agreement that Kenya and Germany signed in September 2024.

"We are working on several initiatives to strengthen the labour movement, and it is crucial for us to hold regular meetings and engage with local communities to keep everyone informed about our efforts," Mwadime stated.

He acknowledged that many people in rural areas are unaware of the current migration policies and pledged to fill this information gap.

"I've actively participated in a number of talk shows to help ensure that all Kenyans are aware of this important information. However, I know there's still a lot of work ahead, and I am committed to making it

happen," he added.

They discussed the visa issuance process at the German Embassy in Kenya with PS Mwadime acknowledging the difficulties that many Kenyans face when applying for visas for employment in Germany.

He expressed gratitude for the recent improvements the embassy has made to streamline the process, highlighting the positive impact the changes have had on individuals seeking opportunities abroad.

"I'm pleased to announce that the German Embassy has successfully addressed ongoing visa challenges. We now have additional visa officers on duty to expedite the processing of applications for qualified Kenyans," Dr. Joachim Stamp said.

As the Special Commissioner for Migration Agreements in the Federal Republic of Germany, Dr. Stamp emphasized that the embassy is now better equipped to handle the growing volume of visa applications.

This positive development heralds a more efficient and streamlined experience for individuals seeking to travel to Germany, he added.

Furthermore, Dr. Joachim emphasized the pressing need for tighter regulations on recruitment agencies that facilitate the placement of Kenyan workers abroad.

## Migori County to benefit from clean energy products

igori County is set to experience a general environment cleanup following the establishment of a green hub by a private investor Company, Women in Cold Chain, Agriculture and Renewable Energy (WICCARE) Africa Limited.

Sub County, within Migori, which would provide green and renewable energy to the local people and beyond.

According to the Company Chief Executive Officer (CEO) Fidoh Kens Ochieng, the investment is a pioneering social enterprise focused on transforming waste into energy while empowering female-led entrepreneurship.

Some of the lined up products to be manufactured by this company through the multi-million investments are alternative cooking fuels, organic fertilizer and other biomass products for green energy.

"Energy is central to WIC-CARE's mission to improve lives and protect the planet through sustainable energy solutions by specializing in

providing high-quality, renewable, clean, and efficient energy alternatives, said the CEO when he took KNA crew on a tour of the Company field site where the construction of the factory is ongoing.

The factory will be fully operational by the end of this year, he announced, adding that WICCARE will also be giving back to the community safe drinking water by drilling boreholes and establishing water kiosks in designated spots within the Nyailing'a Community.

Ochieng said that they will be engaging the Migori County government to access organic waste from markets, a key ingredient material in producing WICCARE products like Biochar, Biomass Pellets, Biomass briquettes, among other products.

## ICT experts urged to strengthen digital governance frameworks

The Head of Public Service and Chief of Staff, Felix Koskei (Pictured), called on ICT experts to lead in shaping Kenya's digital transformation agenda.

He said the experts should develop robust policies, legal frameworks, and inclusive strategies to ensure effective and ethical use of technology and online systems.

Speaking during the Kenya Chapter of the Information Systems, Audit and Control Association (ISACA)'s Annual Conference, Koskei emphasized the critical need for structured approaches to digital governance, un-

derscoring the importance of integrating both certified professionals and self-taught technologists into the formal digital ecosystem.

"We must not leave anyone behind. Those who possess skills but lack certification should be brought into the fold and supported to gain formal recognition. This will help us build a strong and inclusive digital workforce," he said.

Koskei revealed that more than 22,000 government services have already been digitized, a milestone aimed at enhancing efficiency, transparency, and accessibility for all citizens.

"Technology contin-

ues to play a pivotal role in reducing corruption and improving accountability in public service delivery. That is why the government is prioritizing investments in this space," he noted.

The Head of Public Service also outlined an ambitious connectivity strategy which aims to extend fiber optic infrastructure of 100,000 kilometers across the country in the next three years.

The expansion will ensure that all county headquarters, schools, and government institutions have access to high-speed internet, bringing services closer to the people.

He said the government has allocated substantial funding to establish Digi-



tal Hubs and ICT training programs in Technical and Vocational Education and Training (TVET) institutions.

The initiative targets the digital upskilling of 20 million Kenyans, equipping them with the necessary skills to access and utilize e-government services with ease.

"Like right now, we have emerging technologies that are coming up, like the AI strategy that has been launched by the government, we have the cybersecurity strategy as well, which is in the draft phase. The Data Protection Act is undergoing some changes, and we sit in some of these task forces to be able to contribute our expertise," Omolo noted.

## Government introduces digital procurement system to boost efficiency, curb graft

The Government sets up e-GP system, which is part of the broader Public Finance Management reforms, aligning with efforts to leverage technology for good governance, equitable resource distribution and service access



he Government expects to minimise bureaucracy, reduce costs and corruption risks associated with its procurement processes once the digital system introduced last week is fully implemented from July 2025.

The Electronic Government Procurement (e-GP) system, which was launched by the Cabinet Secretary, National Treasury and Economic Planning John Mbadi, is expected to enhance transparency, accountability and efficiency in how Public resources are allocated and utilised.

The e-GP system is part of the Government's broader Public Finance Management reforms. It aligns with the commitment to leverage technology to foster good governance, promote access to services and enhance equitable resource distribution.

Mr Mbadi said e-GP was created in line with the Public Procurement and Disposal of Public Assets Act 1 of 2003

It gives effect to Article 227 of the Constitu-

tion, which states that there must be efficient procedures for Public procurement and for assets disposal by Public entities.

The CS observed that the technology will cut down operational costs by up to Sh300 billion and ensure timely delivery of goods and services, ultimately benefiting mwananchi.

"Government procurement accounts for 60 per cent of the total Budget, which comes to about Sh2.5 trillion. Once the system is implemented to the fullest, Kenya will save over 15 per cent of procurement costs, which is about Sh330 billion," said Mr Mbadi.

County Governments, will be on-boarded on the e-GP starting this April ahead of full roll-out in July 2025.

implemented to the fullest, Kenya will save over 15 per cent of procurement costs, which is about \$h330 billion," said Mr Mbadi.

Once registered, one can browse available tenders and select tenders that they wish to participate in. From there, then can submit their bid documents electronically before the tender closing date.

The Government Entity will then carry out tender evaluation of the submitted documents in line with the criteria provided. The system helps one tracks the status of their submissions through notifications from the portal.

One will then be notified of the outcome (whether successful or unsuccessful).

If awarded the contract, further steps like signing the contract, issuing performance guarantees and contract management will also be handled electronically.

International suppliers are allowed to also use the system as long as they meet the eligibility criteria set by the Procuring Entity and compliance with the legal framework.

Mr Mbadi said the e-GP system will not replace others like Integrated Financial Management System (IFMIS) or Public Procurement Information Portal (PPIP), but will be integrated with them.

For IFMIS, this will help process payment after completion of the procurement process.

Treasury has partnered with the Kenya School of Government to offer training for all procurement personnel. It has also set up a Help Desk and will hold weekly webinars to train people.

Dr Chris Kiptoo, the Principal Secretary, The National Treasury, said the system marks the greatest transformation of the Government procurement process.

"It is a significant step towards achieving transparency and accountability in procurement operations," he said.

He noted that all Budgets of MDAs and County Governments will now be loaded into the Integrated Financial Management Information System (IFMIS) and then linked

"This will streamline budget and payment processes. The system will also simplify auditing processes by providing a clear and accessible trail for review," he said.

Mr Eric Korir, Director of Public Procurement, The National Treasury, said the reform is designed to transform the way procurement and asset disposal are conducted, ensuring transparency.

"The system was piloted at key institutions, including Ethics and Anti-Corruption Commission (EACC), State Department of ICT, Kenya National Highways Authority, Moi Teaching and Referral Hospital (MTRH), Public Procurement Regulatory Authority and Busia, Elgeyo Marakwet and Makueni counties," he said.

He noted that Treasury will oversee training programmes for Accounting Officers, Heads of Departments, Public Financial Management (PFM) officers and Development Partners.

Mr John Karani, the Chairman, Kenya Institute of Supplies Management (KISM) said e-GP system enables Procuring Entities to publish, receive and evaluate tenders as well as award contracts electronically, adding the sector's professionals will embrace it.

xperts have called for stronger oversight of Artificial Intelligence (AI) to nsure its effective use, particularly in the Public Service.

The experts from academia, publishing as well as ICT, who were speaking at a panel discussion on digitisation of Public Service during the Inaugural Africa Technology Leadership Conference 2025 in Eldoret, said oversight would enhance responsible application.

"You need social scientists like communicators for efficient AI use as there must be human oversight. The communicators will guide AI to ensure there no biases in communication." Ms Lilian Kimeto, the Chief Executive officer of the Kenya Yearbook Editorial Board (KYEB), observed. She called for stronger collaboration between technologists and social scientists, adding, "I encourage technology experts to work with social scientists to align AI with human needs. At Kenya Yearbook, we process vast amounts of data and give it meaning. AI can assist, but human judgment remains indispensable."

She noted that the Government has embraced digital technology to improve its processes. About 15,000 Government services are available online, therefore, enhancing efficiency and access.

And to improve the use of emerging digital technologies like AI, the Government two weeks ago launched the AI Strategy 2025-2030  $\,$ to drive up adoption of the technology and ethical use. The Strategy seeks to make the country a leader in AI research and development and promote ethical and responsible use of the technology to curb misinformation, malinformation and disinformation.

According to the Strategy, Kenya will modernise its digital infrastructure and establish a robust and sustainable data

And to enhance adoption of emerging digital technologies, the Government two weeks ago launched Al Strategy 2025-2030 to drive adoption of the technology and ethical use.

ecosystem to hasten adoption and usage of artificial intelligence (AI) in key sectors.

Kenya is currently making great strides in developing its digital infrastructure through investment in the National Fibre Optic Backbone network, provision of free public Wi-Fi and affordable internet services.

Kenya Yearbook is among State agencies that have embraced digitalisation, with Ms Kimeto observing that KYEB presents all its publications in digital formats.

## KALRO receives Sh35 million in equipment to boost rice production

he Industrial Crops Research Centre has received research equipment and machinery to enhance mechanization and improve data collection and accuracy. The Sh35-million equipment, donated by the International Rice Research Institute (IRRI), will also optimize research efficiency, particularly in rice cultivation.

Speaking during the handover event at the KALRO Center in Mwea, KALRO Director General Dr. Eliud Kireger expressed gratitude, emphasizing how the resources would drive innovation and strengthen agricultural research for key crops such as rice, maize, and wheat.

He added that Kenya has a significant deficit and imports a large amount of rice, noting that with mechanization and the use of recommended seedlings, the country could bridge

"As you are aware, we import about 80 percent of the rice that we consume. We produce slightly less than 20 percent. Therefore,

He noted that Mwea is currently the most advanced irrigation scheme in the country and the region in terms of mechanization. Dr. Ismail added that IRRI aims to extend mechanization to all irrigation schemes and rain-fed areas, which will significantly boost rice produc-

"You can easily triple productivity and probably cut the cost by half if you fully mechanize the operations. Farmers can grow rice over very large areas, so mechanization is the starting point for development. It is crucial to transition from hand-held equipment to mechanized equipment that can accomplish what 100 farmers might do in one day," he

Some of the equipment donated were planters, land levelers and accessories, mobile thresher driers, digital devices and tractors which will be used by farmers in the area.

## 15,715 avocado seedlings distributed across Nakuru
